

HEALTH REQUIREMENTS For All New Students and Gr. 7 Students

New students Please upload all documentation during online registration or submit to the school office by **specified due date** to comply with California Department of Public Health and Diocese of Oakland School Dept. regulations.

No student will be allowed entry without required health documentation.

TK and New Kindergarten: DUE MAY 1, 2024

- Proof of immunizations (see Parents Guide to Immunizations Required for School Entry)
- A complete physical exam dated within <u>6 months of entry (on or after March 1)</u> Use the form provided or submit a detailed health exam from the physician, such as Kaiser's form.
 If your child has a physical scheduled after August 1 of incoming school year, contact the office.
- Verification of a dental visit (dental form, letter, or invoice that includes name of student, dentist, and dentist address)
- Tuberculosis (TB) Screening within 6 months of entry (on or after March 1)
 - O A TB risk assessment signed by the physician within <u>6 months</u> of entry is mandatory.
 - o If >1 risk factor present, please <u>also</u> submit one of the following: the result of the PPD/Mantoux skin test," **or** a physician's statement of "negative symptom screening," **or** a physician's statement of "no risk."

New Grades 1-8: DUE MAY 1, 2024

- Proof of immunizations (see Parents Guide to Immunizations Required for School Entry)
- A complete physical exam dated <u>within18 months of entry</u>. Use the form provided or submit a detailed health exam from the physician, such as Kaiser's form
- Verification of a dental visit (dental form, letter, or invoice that includes name of student, dentist, and dentist address)
- Tuberculosis (TB) Screening within 2 years of entry. Must include:
 - o a TB risk assessment signed by the physician
 - o If >1 risk factor present, please <u>also</u> submit one of the following: the result of the PPD/Mantoux skin test," **or** a physician's statement of "negative symptom screening," **or** a physician's statement of "no risk."

All Students Entering Grade 7: DUE MAY 1, 2024

A Tdap booster on or after the 7th birthday is required for all incoming 7th grade students. Please submit immunization record.

Other

Care Plan for Children with Special Needs if your child has a serious or chronic health condition
(i.e. asthma, allergies, diabetes, seizures, etc.) and medication must be administered at school, please
submit this form, signed by the physician, to the school office. It may be obtained from the school office
or webste. The school office will accept other care plans, such as those from Kaiser.
☐ Permission to Carry and Self Medicate This form is only required if your child's well-being is
seriously in jeopardy without an inhaler/medication/epi-pen carried with them, and you wish your child to
carry and self medicate. The Care plan for Children with Special Needs must also be submitted.
